NRW officers Gillian Coates (GC) and Gareth Davies (GD) met with PAUL DAVIES and JOHN JAMES of MERTHYR TYDFIL COUNTY BOROUGH COUNCIL (MTCBC) on Thursday 11 November 2021.

The inspection of permit number BB3092HJ was unannounced and the site was not pre-warned of our visit.

Weather conditions during the inspection were cloudy and dry.

C1 STAFF COMPETENCY AND TRAINING

Condition 1.1.1 (b) *The operator shall manage and operate the activities: (b) using sufficient competent persons and resources.*

You demonstrated compliance with this condition of your permit because a WAMITAB certificate for Paul Davies valid through to 26/07/2023 was displayed on the wall in your reception area. We discussed that John James was booked on to a WAMITAB course to renew his Certificate.

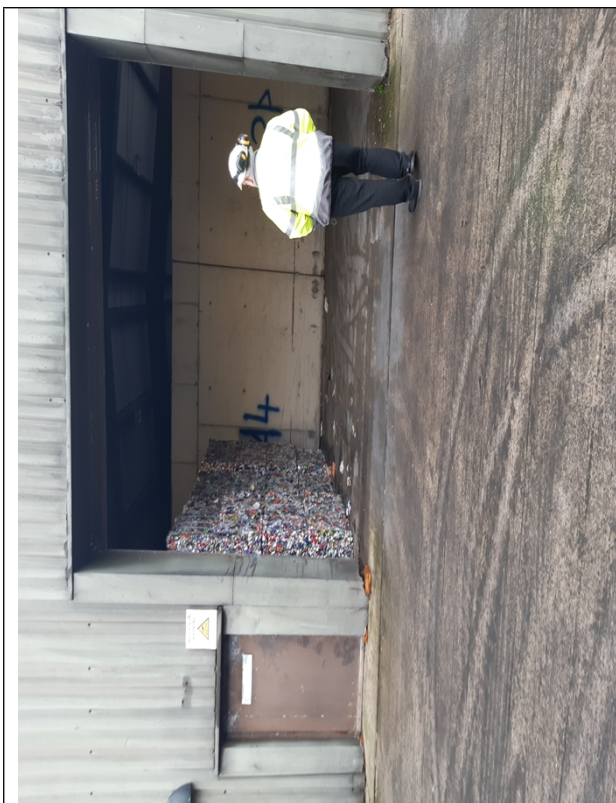
