Reporting of monitored emissions and performance indicators for 2018.

Requirements: Conditions 3.5.1 and 4.1.2 require the operator to undertake annual monitoring of point source emissions and performance indicators and to report the results to Natural Resources Wales as specified in Schedules 3 and 4 of the permit. Condition 4.3.5 requires notification to NRW of changes in the activities taking place on site where they are not subject to a permit application.

Findings:

Reports for monitoring of emissions to sewer, waste recovery and disposals, water usage, energy usage and specific performance indicators were received on 08/02/2019 containing the required information. It is noted that increases in specific water and energy use and COD discharges are related to the cessation of cheese manufacturing on site.

A mothballing plan was submitted by email on 08/08/2018 to reflect the winding down of cheese production in July 2018 and continuation of packaging of product on site.

Action: Ensure site procedures in place during the mothball period are adequate to meet the monitoring and reporting requirements, even if submissions are nil returns.

Action: The operator should provide a brief update on progress with the specified steps within the mothballing plan, particularly with regard to removal of product, chemicals and refrigerants from the site. A copy of the plan is attached to this CAR form for reference.

Please contact NRW at the earliest opportunity to discuss any planned changes to the permitted activities on site and continue to comply with the 14-day notice period required by Condition 4.3.5.
