- Reviewed the pro-active odour surveys that are currently being undertaken twice per day. We agreed to reduce this to twice per week. One survey on a Friday afternoon after 3pm and one survey on a Monday. However, if an odour complaint is received then a survey will be undertaken immediately as an addition to the routine ones.
- No odours detected during this inspection on site or in the community.
