Condition 2.2.1.3, Table 2.2.2 Emission limits to air – Multiple low level exceedances reported to Natural Resources Wales through Part A Notifications for Q3, Q4 2018 as required by the environmental permit, summarised as follows:

NOx 400 mg/m3 - range 432 to 765 mg/m3 various times Sept, Nov and Dec,

Particulate 10 mg/m3 - range 10.2 to 17.8 mg/m3 various times July to Nov,

CO limit 100 mg/m3 - range 121 to 1672 mg/m3 various times July, Aug,

VOC limit 20 mg/m3 - range to 22.2 mg/m3 various times July, Aug.

Operating conditions adjusted to bring back into compliance.

Consolidated CCS3 as considered to be potentially a function of variable operation run times and the whole process requires a detailed review.

Action: Review operation of the organic residues incinerator to improve compliance and submit a summary report to Natural Resources Wales by 30 June 2019.
