NRW was notified by a member of the public on 6th September 2015 at 1903h that there had been a visible release of dust from the Meltshop between the period 1430 to 1530h.

Upon further investigation Celsa confirmed that there had been a failure of the dedusting plant during a furnace melt. The failure occurred as 11 out of 20 compartments on the plant were in fault mode due to a problem with the emergency dampers. Scrap melting was halted when this was confirmed but it was not possible to prevent the release of dust to atmosphere. Normal abatement efficiency was reestablished when the plant was able to be restarted.

Celsa acted promptly to this incident and shut down the EAF as soon as possible to minimise impact of fugitive dust releases. There is also no history of poor plant performance. Under normal circumstances the dedusting plant is very effective at meeting the permit limits. However, a single Cat 3 non-compliance has been recorded due to the release to atmosphere from an unauthorised source.

Celsa provided NRW with a copy of their Symptom-Cause-Remedy-Action report. This noted that it was known that the emergency damper was faulty but it had not been logged on the SAP. While the faulty cyclinder was replaced on 10/9 if the repair had been actioned earlier then the plant failure may have been avoided.

Action: Celsa must ensure maintenance procedures are carried out to high standards and fault logging is not over looked.
