Celsa provided a series of documents and comments in response to the Actions identified on CAR form TP3639BH/0247790 on 25th September 2015. These have been reviewed and the following comments are provided in respect of the individual actions.

Non conformance E1, Action (1): A work instruction for operation of the Lancing Booth, inspection reports and maintenance work records were provided. Action complete

Work Instruction : Document WI-CE-MIN-0034 whilst detailing the operating instructions contains some errors and a significant omission.

It is stated on p5 and 9 that when skulls are to be lanced in the open prior notification must be provided to the Local Authority. This is incorrect. Condition 2.3.7 of the permit makes explicit reference to this situation and it is this requirement that must be satisfied in advance of any proposed lancing external to the booth.

The WI makes no reference to the monitoring requirement as stated in Table S3.1. This requires that emissions from the Lancing Booth stack comply with Ringlemann Shade 1 and this must be monitored on a daily basis (each day that lancing is undertaken) and recorded. Celsa must implement such a procedure and ensure the records are retained. **Action (1): Celsa** The inspection reports provide evidence of quarterly inspections. There is a wide range of inspection topics including 'Condition of Filters' which suggests the inspection process is both regular and thorough. However, it is noted that the same comments appear on successive inspection reports e.g. 'Fire proof material that has burnt out of front still requires replacing', 'Filters require inspection when unit not running. Possible filter change'. This suggests the process for close out of required work is poor. **Action (2) Procedures should be in place to ensure timely close out of required work.**

The maintenance records provided make reference to some of the maintenance work but appear incomplete as some of the boxes for 'Actual Completion' are blank.

Non conformance F3, Action (2): A copy of the management plan for Triple R's activities should be provided prior to recommencement of the screening operation. **Action remains outstanding.**

Action (3): NRW await a copy of the report. **Action remains outstanding.**
