NRW were notified by letter dated 1st August 2017 of Celsa's intention to use a mobile slag crushing plant on the Mineral Site. Permission was granted for this - CAR_NRW0031968.

A visit was arranged to the Mineral Site to witness the crushing activity and confirm the extent of any environmental impact.

The crusher was operational at the time of observation. It was processing mixed grade slag that was being loaded by a three tonne capacity bucket loader. The crusher jaws had been set to 120mm. There was an integral water spray (within the crusher) to minimise fugitive dust releases. The slag being loaded was of mixed size so only a proportion was being size reduced. Noise levels were generally low with no significant fluctuation depending upon work load. Fugitive dust releases were minimal. Celsa had arranged for a bowser to be on duty for the duration of the work but at the time of observation this was not required. The slag processing rate was steady.

The crushed slag output would be screened using the normal Mineral Site equipment to produce the final graded product for sale.

Overall the operations were being well managed and there was no significant environmental impact.

Celsa need to make separate requests to NRW for any future crushing campaigns, however, on the basis that the work would adhere to the same standards and use similar equipment such a request would not need to be as detailed as that provided in this instance.

It was noted that the Mineral Site windsock was not functional. This provides a good indication of the wind direction on site and the potential areas that could be affected by any fugitive dust releases. It should therefore be reinstated as a matter of urgency.
