Minor Operational Change

Celsa have provided notification to NRW (received 15th December 2014) of a minor operational change. The plan is to commence use of a mobile screening plant to enable further processing of scrap screenings recovered from the scrap bay. This will be for a trial period of 4 weeks with a start date of 8th January 2015.

NRW agree to these proposals.

Celsa should provide confirmation to NRW of the start and finish date of the actual trial programme.

Permission for the trial is agreed on the basis that there is no detrimental environmental impact. As described in the provided documentation fugitive dust releases from the operation must be adequately controlled.

If the trial is successful Celsa must provide further notification if it becomes the intention to adopt the process on a permanent basis.
