The permit includes a limit on onsite EAF dust storage of 1000t (Permit Condition 2.1.1, Directly Associated Activity A9). Due to circumstances beyond Celsa's control the company who store the dust offsite prior to despatch under TFS for recovery overseas, needs to relocate its operation. A permit for the new location is likely to take up to four months to obtain. Celsa have provided details of an onsite area that can be used for temporary storage of bagged EAF dust pending a permit being granted for the new offsite storage location.

NRW agree to the use of the identified area (within the existing installation boundary as detailed in Email from Richard Lewis dated 30 March 2016) for the temporary storage of bagged EAF dust and that the restriction on storage inventory is suspended. This will be effective for a period of six months, commencing from the date of this CAR form.
