Celsa provided a response to NRW in respect of Improvement Condition 3 on 3rd February 2016. The following comments are noted;

BAT 10 - NRW accept that Celsa have made improvements in recent years that have reduced the environmental impact of handling, storage and transport of solid residues. Critical to this have been improved management practices and the increased use of water sprays at key locations. It is vitally important that these standards are maintained. A significant area of concern remains the slag quenching and transfer area that still has the potential to contribute to significant releases to air if not managed correctly. It is also appreciated by NRW that the hooding of such a large area may not be the most effective means for minimising such releases. However, Celsa must continue to maintain existing standards and look for relevant options for ongoing improvements. If there is any evidence of deterioration of these standards then the suitability of existing measures would need to reassessed.

BAT 16 - Celsa are continuing to monitor the impact of diffuse emissions using the Topas and deposition gauges. These have tended to indicate ongoing reductions in local dust deposition.

BAT 89 - Celsa have demonstrated that the EAF can meet the stricter PCDD/F limit on an ongoing basis.
