Celsa Manufacturing (UK) Ltd. requested on 6th June 2018 permission to undertake lancing external to the lancing booth for a two week period. This is to enable large skulls that are too big to lance in the dedicated booth to be cut up. The activity is permitted under the permit but only following Celsa seeking written agreement in accordance with Permit Condition 2.3.7.

NRW permits the lancing to be carried out on the basis that appropriate measures are taken to avoid any off site impact from released fume.

Celsa should advise NRW when the programme of work is complete.

NB NRW's response to Celsa was delayed due to the normal inspector being on leave.
