Celsa Manufacturing UK Ltd. provided notification to NRW (received 16/01/2018) that they plan to use a mobile screening plant on site for a six week period commencing 30th January 2018. This is for the purpose of screening scale to improve the product quality for existing and prospective customers. Notification is required in accordance with Permit Condition 2.3.6. Similar equipment has been used on site previously without any significant environmental impact. The screener will be located on the Mineral Site and operational hours will be restricted to 0600 to 1800h.

In view of the occasional complaints that are received in respect of fugitive dust releases from the Mineral Site Celsa should be cautious to ensure such releases are abated as necessary. While there is no specific indication that fugitive dust releases from the Mineral Site will increase during the screening operations, Celsa should review the on-going performance of the equipment and take proactive measures if at any stage dust releases have the potential for off site impact. It will also be prudent to consider the contribution of the prevailing meteorological conditions, specifically wind speed and direction together with any recent dry periods.

On the basis that such procedures are adopted and when necessary appropriate measures implemented NRW have no objection to the proposal.
