Celsa Manufacturing UK Ltd. notified NRW by letter, received 2nd March 2017, that they plan to commence use of a mobile screener at the Mineral Site for the purpose of scale processing. This is intended to increase the marketability and value of this waste stream. The notification was provided in accordance with Permit Condition 2.3.6 and 4.3.5.

The notification has been assessed and the following comments are provided:

- The intention is to trial the process for a 4 week period and if successful adopt on a permanent basis. Following the trial Celsa need to provide NRW with a summary report of the trial outcome and comment in respect of the further queries below. This should be provided by **30th April 2017**.
- The proposed machinery has a high capacity at 400t/h. If the process is adopted on a permanent basis will the same capacity machinery be used as this appears to be very large compared with on going scale production quantities?
- Although the machinery will be operated by the mobile plant hire company Celsa need to take all necessary steps to ensure the operational standards do not lead to a non-compliance with permit conditions.
- While particulate matter or dust emissions are not anticipated Celsa must confirm this during the trial by general observation and implement necessary abatement in the event of significant releases.
- While noise and vibration issues are not anticipated Celsa must confirm this during the trial by general observation. In the event that such observations suggest there are issues survey work may be appropriate.

Note for future reference that Notifications in accordance with Permit Condition 4.3.5 are required to be provided 14 days in advance of the proposed commencement of the change in Operations.
