In addition to the above mandatory reporting Celsa have also provided Deposit Gauge data on a quarterly basis (monthly deposition measurements)

Throughout the year Celsa have also provided to NRW Schedule 5 Notifications as a result of emission limit exceedances or other notifiable incidents. Comment in respect of these has been provided on separate CAR forms.

It is confirmed that Celsa have satisfied all the permit reporting requirements during 2014.
