Any more accurate information on the matters for notification under Part A.	A roof locking fault occurred on two occasions during the 04.59-05.59 and 06.59-07.59 melts. A minor trimming delay was experienced while the first basket was charged during the 02.59-03.59 melt. This would have meant the roof was open for a short period before power was applied. Additionally, the shift report noted that a DED duct damper was intermittently faulting. This issue has now been resolved.
