During the investigation into the CO and particulates concentrations recorded, it has been identified that water leaks in the T1 and T2 ducting within the quench tower are preventing complete combustion. This results in higher than normal off gas emissions. Temporary maintenance and patch repairs of the ducting will be undertaken on a weekly basis during planned shutdowns. During the annual two week maintenance shutdown in May, the ducting panels are to be replaced.
