Any more accurate information on the matters for notification under Part A.	Brown/grey smoke was observed to travel along roof of the scrap bay due to high wall backing and an inspection of Rover Way confirmed no smoke in roadway. Emergency response was controlled by the Fire Service and onsite water hydrant filled bowsers were used to extinguish the fire. Minimal run off was observed due to high levels of evaporation. The remainder was discharged as effluent. An internal investigation was undertaken and a number of actions have been taken to prevent a reoccurrence, such as halting work on the scrap bay rails until new risk assessment and method statement have been produced. Safety communications of risk perception are also being issued.
