Celsa Manufacturing provided a Schedule 5 Notification on 16/8/2016. This advised NRW that on 15/8/2016 during the course on maintenance work being carried out in the North Scrap Bay hot work resulted in combustible material in category 1 and 2 scrap being ignited. The resultant fire was attended by the FRS.

Following the incident an internal investigation was undertaken and actions identified to prevent reoccurrence, this included revised risk assessments and method statements.

A single Cat 3 non-compliance is recorded as a result of Celsa failing to have appropriate procedures in place to minimise the risk of such occurrences prior to completion of the maintenance work.
