### **Annual Reporting Forms A2, E1, PI1, R1, S1**

All necessary data has been reported. The concerns related to the period of sampling for annual dioxin measurement have been addressed by Celsa but NRW have advised that the Site Specific Protocol for the relevant monitoring campaign must reference the monitoring period that is stipulated in the permit and this should be adhered to.

### **Permit Condition 4.2.2 Annual performance report**

Celsa's approach to maximise efficiency continues to reap some on going, albeit small, performance improvements for what is a well developed energy intensive process. Realistic but achievable targets have been set for 2017.

Celsa have started to remove scrap screening waste from the installation. As noted in previous CARs it is important that waste outlets for this material match the rate at which it is being generated otherwise it is not a sustainable process.

### **Quarterly data reported during 2016**

Celsa have provided all the required quarterly monitoring data during the year. Where non-compliances were identified separate comment has been provided on CAR forms.

### **Topas Monitoring Data**

In accordance with the permit requirements Topas monitoring data for PM10 and PM2.5 has been provided. Improvements have been made to the Topas servicing contact. This should help ensure periods when monitoring data is not available are much less frequent.
