An investigation has been initiated into the particulate breach. The first part of the investigation is reviewing the de-dusting plant filtration system, to ensure that it is working efficiently. The outcomes of this initial investigation will determine the next steps for review. As soon as further details are provided from the Melt Shop, we will implement any corrective actions and inform NRW accordingly.

The Melt Shop then initiated a down period in order for the breach to be welded, which has successfully rectified the issue causing the particulate breach.
