On the 11 th June 2018, the Melt Shop conducted checks on all 20 compartments of the de-dusting plant, in order to replace any damaged bags. Following the initial investigations within the de-dusting plant and pre start up checks, the Melt Shop shut down at 23:37 on the 11 th June due to continuously high particulate levels.
