Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This is a permit variation following the publication of the revised Best Available Techniques (BAT) Reference Document (BRef) for the Food, Drink and Milk Industries. The associated BAT conclusions to this document were published on the 4 December 2019 in the Official Journal of the European Union.

This variation incorporates the changes required by the Industrial Emissions Directive following a statutory review of permits in the Food, Drink and Milk Industries sector. These include the amendment of the wording of several permit conditions relating to notifications, changes to emission limits and monitoring requirements. The interpretation section of the permit has also been updated and the opportunity has been taken to consolidate the original permit and subsequent variations.

We are satisfied that the operator will be compliant with the published BAT conclusions which will apply from 4 December 2023.

The rest of the installation is unchanged and continues to be operated as stated in the permit.

The schedules specify the changes made to the permit. Schedule 1 of the notice specifies the conditions that have been varied and Schedule 2 comprises a consolidated permit which reflects the changes being made.
