3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

This was an unannounced site inspection carried out to check compliance with the recent permit suspension notice served on the 8th December 2021. The site inspection was carried out by waste regulation Officer Amy Henderson and Hazardous Waste Regulation Officer Kathryn Bradshaw.

On arrival at site the gates were closed and a lorry arriving was turned away. Plant machinery could be seen pushing soil material on the site, but no acceptance or treatment or waste was taking place.

Regulation Officers met with Carl Smith, acting site manager. Who stated they were having a tidy up onsite and had therefore not opened at that time. Carl Smith stated he was not aware of the most recent suspension notice. However as the site was not operating at the time of the visit, they site were not found to be in breach of this.

Conditions of the notice were explained to Carl Smith and an additional paper copy provided.

The site has still not appointed a suitable Technically Competent Manager as required under the permit conditions 1.1.3, 1.4.1, 1.5.1 and detailed in CAR form ref CAR_NRW0039053. As there is on-going enforcement regarding this, a repeat Cat 2 score for this non-compliance has been suspended.

An action has been given for the site to appoint a suitable Technically Competent Manager and confirm with Natural Resources Wales details of their qualifications. The permit remains suspended in full until this action has been met.

The site's drainage also remains not in compliance with conditions 1.1, 2.1.1 & 2.1.2 of the permit. Again due to the on-going enforcement regarding this issue a repeat Cat 2 non compliance score has been suspended.
