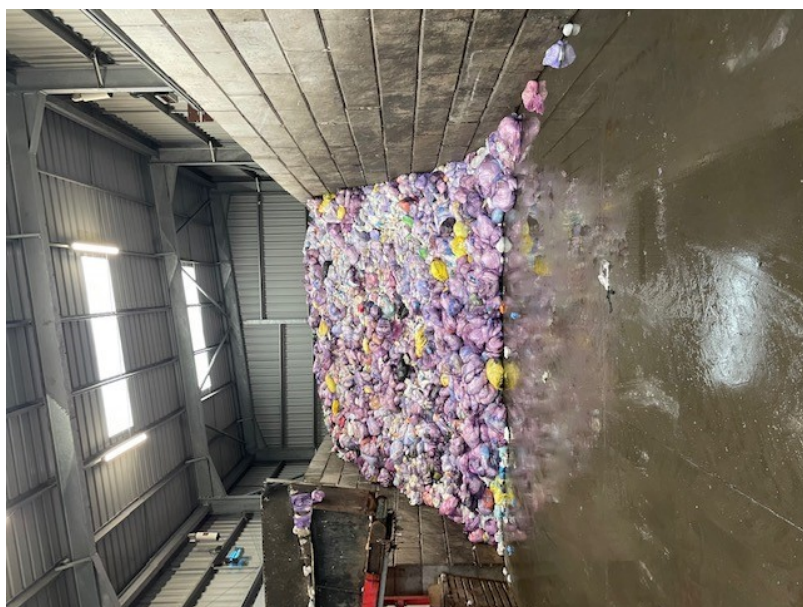
Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This is the first physical inspection prior to my virtual inspection earlier this year. In terms of general management Mr Poyer has now updated his Certificate of Technical Competence Level 4 Management and Treatment of Hazardous Waste (Clinical). This is valid from the 17/12/21. The volume of waste on site was well below the 50 tonnes. There was a small amount of 18 01 04 waste waiting to be processed in the processing bay.



The external areas were clean, with drainage areas colour coded and open drains free from debris. There were no odour issues identified on site and no complaints received. The external bin storage area was well stocked.



At the front of the yard the impermeable pavement was in good condition. The infectious clinical waste was stored separately and labelled appropriately. These containers were locked and stored in a secure area within the site.

The site was in good working order with excellent housekeeping and working practices.
