4. Details of our assessment

The Bryn Posteg Landfill Site was visited for a pre-arranged, routine inspection on Tuesday 7th December 2021 by Natural Resources Wales (NRW) officers Paul Challender & Jamie Blythin. The inspection took place on the day of Storm Arwen and as such winds were high and there was significant surface water due to heavy downpours in the morning. Officers Challender and Blythin met with the Technical Manager, EH&S Compliance Manager and Site Manager before inspecting the site's various functions covered by various Environmental Permitting Regulations (EPR) permits. Officers were escorted by the Site Manager only, during the inspection. This Compliance Assessment Report (CAR) covers the composting facility permitted area only.

The composting facility has ceased accepting green waste over winter. The pad is full. The in-situ material comprises of a pile of finished compost, a pile of compost awaiting sorting by particle size and a pile in the process of composting. Compost finished on this pad is still not attaining PAS100 status and as such is still a waste material and subject to legislative waste controls.

Despite a torrential downpour directly prior to inspecting the site and other areas of the landfill draining the resulting surface water, the composting pad itself was not suffering from ingress of surface waters arising from other areas of the landfill site.

Actions from earlier CAR forms in relation to the *Compost pad leachate lagoon construction works method statement and Construction Quality Assurance Plan* are still outstanding. Actions in relation to these earlier CAR forms should be complied with by the deadlines stated in those CAR forms.

Q3 Waste Returns

Waste returns for July - September 2021 (Q3) were submitted to NRW as per permit conditions. On the *Waste Removed* tab a quantity of EWC 19 05 99 is listed as being removed. Guidance on the classification and assessment of waste - Technical Guidance WM3, states that "99" codes should be used only when another category cannot be identified as suitable.
