### 4. Details of our assessment

This was a pre-arranged site visit Carried out by Waste Regulation Officer Amy Henderson accompanied by Steven White (Senior Waste Regulation Officer) and Dave Morris (Central

Enforcement Team).

The purpose of the visit was for NRW Officers to meet with the new Company Director Sean O'Grady who took over as Director for Mold Investments from the 20th December 2021. We were also met by Patrick Hughes, Company Shareholder. The site was not operational at the time of the visit.

Regulation Officers explained the detail of the suspension notices which are currently in place at the site and what was needed to bring the site back into compliance with the permit. The future plans for the site, now it is subject to new management, were discussed.

The permit will remain suspended until the actions listed on the suspension notices are completed.

The site does not plan to operate for the forthcoming winter months.

It was discussed that as part of the full suspension notice, signs need to be displayed at the entrance stating the site is currently unable to accept waste under permit EPR/TB3590HJ. An action has been listed to ensure that these signs are put in place.
