4. Details of our assessment

The Bryn Posteg Landfill Site was visited for a pre-arranged, routine inspection on Tuesday 7th December 2021 by Natural Resources Wales (NRW) officers Paul Challender & Jamie Blythin. The inspection took place on the day of Storm Arwen and as such winds were high and there was significant surface water due to heavy downpours in the morning. Officers Challender and Blythin met with the Technical Manager, EH&S Compliance Manager and Site Manager before inspecting the site's various functions covered by various Environmental Permitting Regulations (EPR) permits. Officers were escorted by the Site Manager only, during the inspection. This Compliance Assessment Report (CAR) covers the Materials Recycling Facility (MRF) permitted area only.

The MRF is still not in use. Despite a torrential downpour directly prior to inspecting the site and other areas of the landfill draining the resulting surface water, the MRF itself was free from standing water. A small pile of scrap metal arising from work on the facility was stored on the pad and tyres were still present in an external bay.

The operator is reminded of the actions and advice & guidance given in CAR_NRW0036821 prior to the recommencement of permitted activities:

- The operator must provide NRW with proposals for remediation of cracks of impermeable pavement prior to recommencement of waste acceptance.
- The operator must give NRW notice of planned date of recommencement of receiving wastes following cessation as per Permit Condition 1.10.1.

Furthermore, a skip stated to contain ash from the on-site Small Waste Incineration Plant was present within the MRF permitted area. This stored ash is discussed in CAR_NRW0039119.
