Form W1, Emissions to Water for 1st January 2021 to 30th June 2021 was received on 22nd December 2021 after Natural Resources Wales (NRW) queried why it had not been received by the due date. RMR are reminded that it is the operator's responsibility to submit all reports required by the permit by the due date specified in the permit. It is not NRW's responsibility to remind operators to submit reports.

Reports must be submitted even when there are no results to report. RMR should explain why no results are available.

This report was six months late and RMR have therefore been issued with a Cat4 non-compliance.
