4. Details of our assessment

A schedule 5 notification has shown a breach of permit limit for effluent discharge from your

facility into to the Afon Erch.

The breach in question on this occasion is for Aluminium. This breach was sampled on the 15/12/2021.

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for Aluminium is 1.0mg/l and the value reported was 1.2mg/l

The result is over the permitted limit and is therefore in the context of this discharge considered a minor breach.

The CCS score on this occasion is a CCS 3.

This breach appears to have been caused by changes to plant commissioning of the new ETP with tighter limits being applied to the new consolidated permit. Adjustments to the chemical dosing system should enable the site to comply with this revised condition in future. Site has addressed these issues in the schedule 5 response to the breach in compliance.
