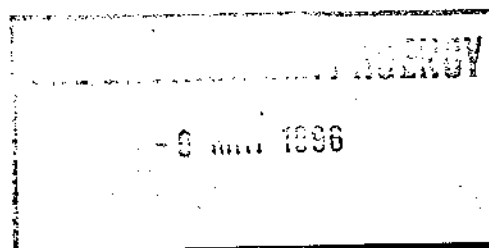

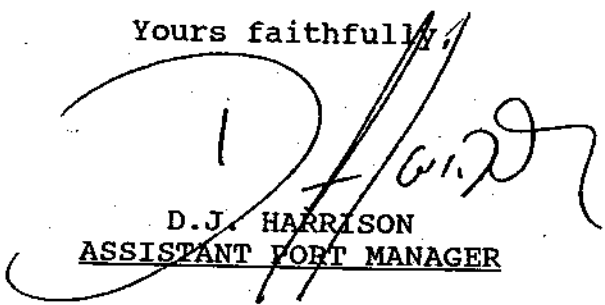
Reference your letter and enclosures of 2nd April, 1996 addressed to my Head Office. Please find appended the schedule and notice endorsed as requested.

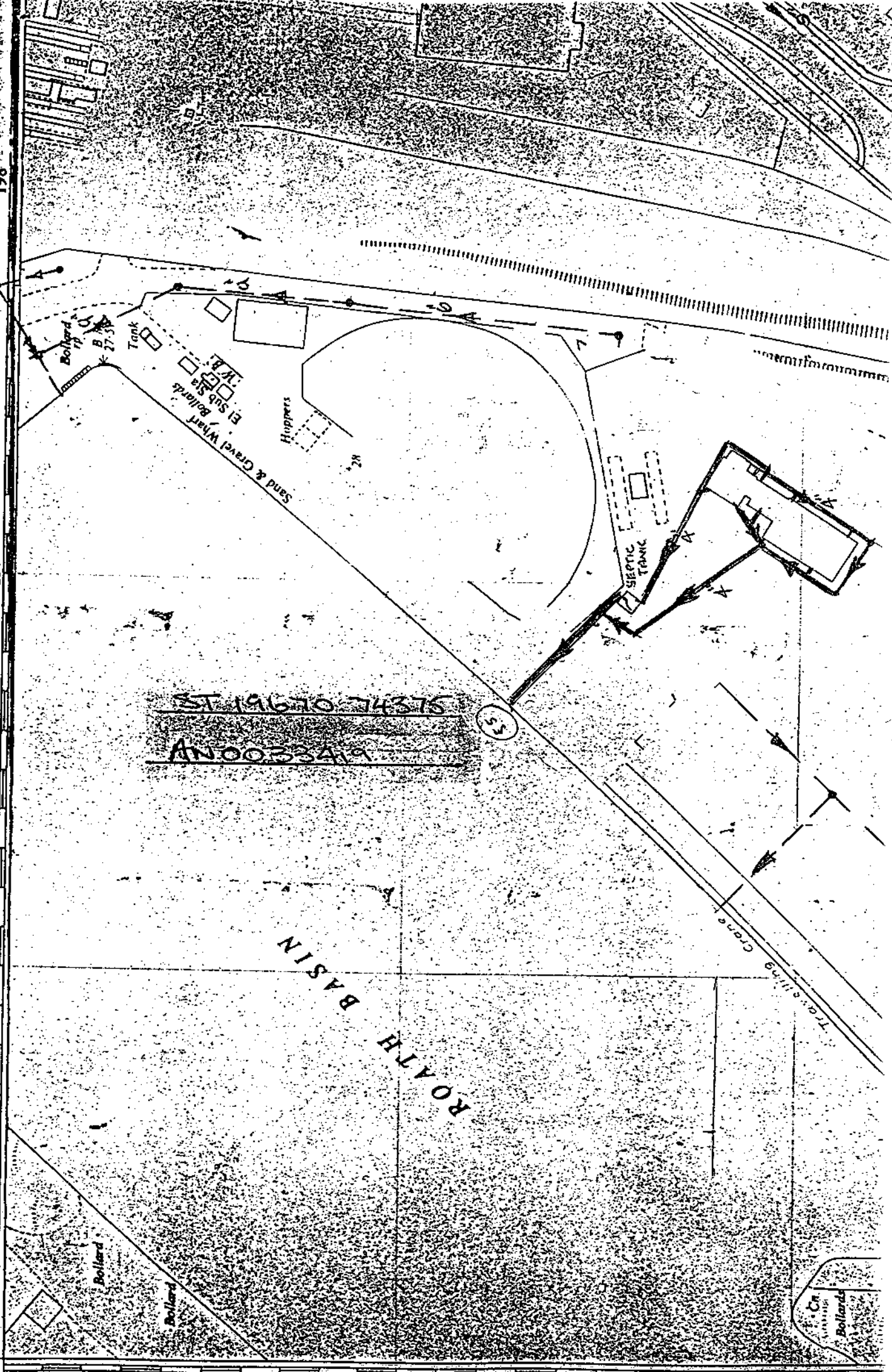
