1 INTRODUCTION

1.1 The Scheme

- 1.1.1 Etive Ecology Ltd was commissioned by Platts Agricultural Ltd to undertake a desktop ecological appraisal of land within a 500m radius of Platt's production unit on their Miners Road site, Llay Industrial Estate North. The application site is centred on National Grid References SJ 32077 56370.
- 1.1.2 The client originally submitted a waste permit application to NRW via ECL Ltd. The proposed scheme is to turn pre-consumer wood residues into animal bedding, along with producing a conditioning agent, within their existing enclosed unit on Miners Road. The permit was initially rejected and put on hold due to the lack of ecological data submitted at the time. The absence of any potential receptors identified meant that they could not be considered in the original risk assessment by ECL Ltd.

1.2 Scope of this Report

- 1.2.1 Although only a desktop ecological appraisal has been undertaken, the assessment of the proposed application is broadly based upon the *Guidelines for Preliminary Ecological Appraisal* (Chartered Institute of Ecology and Environmental Management, 2017) and is informed by recent COFNOD data. In addition, a single site visit was made to assess the current status of the former GCN mitigation area which was created in 2001 and lies adjacent to the west of, but outwith, the application site boundary.
- 1.2.2 The aim of the assessment is to obtain information on the existing ecological composition and value within a radius of 500m from the production unit, and to conduct a preliminary assessment of the likely significance of ecological impacts. To achieve this, the following steps were taken:
- The field survey area and the 'zone of influence' of the scheme, have been identified.
 - The client issued a detailed description of the production operation involved in making the animal bedding.
 - A desk study has been undertaken by purchasing data from COFNOD (the North Wales Records Centre), utilising freely available sources of information and local knowledge of the site.
 - Baseline information on the site and surrounding area has been extracted from the Phase 1 habitat survey (JNCC 2010) data supplied by COFNOD and consideration of notable and/or protected habitats and species (IEA 1995) also included in the data.
 - A visit to assess the current status of the former GCN mitigation area to the west of the site was undertaken in December 2021.
 - The ecological features found to be present have been evaluated (CIEEM, 2019).
 - Invasive plant and animal species (such as those listed on Schedule 9 of the Wildlife & Countryside Act [WCA]) have been identified, if any.
 - Any potentially significant ecological impacts have been identified.
 - Mitigation recommendations have been provided based on current information.
- 1.2.3 An ariel image of Platts production site has been included in Appendix A (taken from Google maps) and current photos of the former GCN mitigation area.

2 METHODOLOGY

2.1 Desk Study

2.1.1 Due to the nature of the application (prescribed activities within an existing industrial building), a desk study was undertaken to identify any nature conservation sites within a radius of 500m from the production unit itself (although COFNOD provided data for 1km). The desk-based exercise also considered the potential for protected and/or notable species of fauna to be found within 500m of the unit.

2.1.2 The following sources of information were utilized:

- MAGIC website (<http://www.magic.gov.uk/MagicMap.aspx>)
- Wrexham County Borough Council website (<http://www.wrexham.gov.uk>)
- Natural Resources Wales website (<https://naturalresources.wales/>)
- Wales Biodiversity Partnership (<https://www.biodiversitywales.org.uk/>)

2.1.3 A data request was made to the North Wales Environmental Information Service (COFNOD). Despite a reasonable level of existing knowledge for the site and surrounding area and additional freely obtained information, it was considered prudent to purchase additional data to support the permit application. The undertaking of a walkover survey of the whole 500m radius was considered unnecessary due to the 'development' being existing and the application activities requiring no land-take or habitat loss and taking place mainly within an existing industrial building.

2.2 Extended Phase 1 Habitat Data

2.2.1 The data was received on 4th October 2021 and lists chronologically the dates that the various records were taken and identified.

2.2.2 Within the data is a Phase 1 Habitat Survey of the search area, which will have been collected by way of the standard survey methodology which follows the habitat assessment and classification procedure outlined by the Handbook for Phase 1 Habitat Survey (JNCC, 2010), whereby all habitats are identified, described and mapped using a standard classification.

2.2.3 The species records provided by COFNOD have been used to provide an 'extended' component of the Phase 1 Habitat data, which has been developed from the methodology described in Guidelines for Baseline Ecological Assessment (IEA, 1995). All habitats and features within the survey area have been subject to a desk-based assessment for their potential to support legally protected or notable species (nationally or locally).

2.2.4 These species include:

- **Amphibians:** ponds within 500m of the site were noted and assumed to provide suitable habitat for a range of amphibians, including great crested newts (GCN). GCN records within a 500m radius were noted and considered.
- **Reptiles:** the vicinity of the production unit was assessed from the Phase 1 Habitat map and from aerial imagery for suitable habitats such as rough grassland, cloddiau, brownfield sites and habitat edges in general which would provide cover, basking and foraging habitat for reptile species.

- **Otters and Water voles:** any watercourses within 250m of the site were noted and any records of these species will be discussed with regards any impact upon them.
- **Bats:** any records for bats within the search area will be discussed and assessed according to the nature of the proposal.
- **Birds:** bird records were noted and the listed and mapped habitats were assessed for suitable habitats for nesting birds, including habitats suitable for ground-nesting species.
- **Badgers:** any records for the species are noted and discussed in the assessment.
- **Invasive plant species:** this assessment does not constitute a full Schedule 9 species survey. Any records for Schedule 9 species were noted and discussed in the assessment.

2.2.5 It was considered prudent to inspect and assess the former GCN mitigation area which was created as part of a consented scheme in 2001 (Planning Ref: P-2001-0590).

2.3 Assessment of Ecological Value

2.3.1 The value and sensitivity of ecological features was determined based on the guidance given in *Guidelines on Ecological Impact Assessment* (CIEEM, 2019). Individual ecological receptors (habitats and species that could be affected by the development) as identified in the record search were assigned levels of importance for nature conservation in one of the following categories:

- International
- UK
- National
- County
- District;
- Local, or
- within the immediate zone of influence or site only.

2.3.2 For a given receptor, determination of value includes consideration of the size, secondary or supporting value/function, conservation status and quality of the species or feature.

2.4 Limitations

2.4.1 Due to the nature of the proposed application (for a Waste Permit for activities within an existing operational building), the lack of a Phase 1 Habitat Survey is not considered to be a limitation as there is no land-take or other physical activity (with significant disturbance) proposed. In addition, given the current land use and management of the production site as a whole, no semi-natural habitats are present within the production site footprint and no legally protected/notable species are considered likely to be present.

2.4.2 There are considered to be no significant limitations to the accuracy of the subsequent desk-based ecological appraisal.

3 RESULTS

3.1 Desk Study

Designated Sites

- 3.1.1 There is one statutory designated site for nature conservation located just within 1km of the application site, but none within 500m. The designated site is the Llay Bog SSSI which is of interest as a lowland raised bog and supports a number of *Sphagnum* moss species which are specific to this continually waterlogged peat environment.
- 3.1.2 There are no Local Wildlife Sites (LWS) within 500m of the application site but three within 1km; Alyn Waters, Blast Road Pond and Rhydyn Hall Grassland.
- 3.1.3 A number of ancient woodland sites are identified within 1km of the application site but none within 500m.

Species Records

- 3.1.4 Species records summarised below are taken from the COFNOD data search for records within 500m of the site. Full details of the Cofnod data are provided in Appendix B:
- Amphibians; there are numerous recent records for great crested newts (GCN) and other amphibians between 250m and 500m from the application site.
 - Bats; there are no records for bats (or other mammals) <500m of the application site.
 - Birds; numerous bird species including notable species such as lapwing, willow warbler, kestrel, long-tailed tit, song thrush, swallow, dunnock and whitethroat are recorded in the study area.
 - Invertebrates; small heath and wall butterflies < 500m of the application site.
 - Reptiles; no reptiles were identified <500 of the application site.

Environment (Wales) Act 2016

- 3.1.5 Section 7 of the Act replaced the 'Biodiversity duty' in Section 40 of the Natural Environment and Rural Communities (NERC) Act 2006, which requires all public bodies to have regard to biodiversity conservation when carrying out their functions. This is commonly referred to as the 'Biodiversity duty'.
- 3.1.6 The Section 7 list is now used to identify those habitats and species of Principal Importance in Wales under the Environment (Wales) Act. The following relevant habitats and species identified within 500m are found on this list:

3.2 Phase 1 Habitat Data

- 3.2.1 The waste permit application is for activities within an existing unit at Platts Agricultural Ltd, situated on Miners Road, Llay Industrial Estate North. The Platts production site covers an area of approximately 1.56ha and is comprised almost entirely of hardstanding with various buildings and containers around the perimeter. Immediately abutting the western boundary of the production site is a 10m wide strip of undisturbed scrub that was created and fenced off as part of a GCN mitigation area creation in 2001.
- 3.2.2 Immediately to the south, east and north-east are further industrial units comprised of hardstanding and various buildings/structure. To the north, west and south-west are agricultural fields comprised predominantly of improved grassland. The OS map and COFNOD records indicate that there are a number of ponds located between 250m and 500m from the application site.

Habitats

- 3.2.3 The eastern edge of the site abuts Miners Park and is marked by some ornamental planting and *Leylandii* hedging to the south of the entrance. On the whole, the area to the east resembles a typical industrial estate with hardstanding, industrial buildings, roads and entrances with occasional hedges and patches of amenity grassland.
- 3.2.4 Land immediately to the south and south-east of the production site is also industrial estate. At a distance of ~250m to the south/southeast is the former Llay colliery which is dominated by areas of bare ground and spoil heaps, with occasional scattered and dense scrub.
- 3.2.5 To the north, west and south-west are intensive agricultural fields; improved grassland and occasional arable crop fields. To the west of the site there is a 10m wide strip of scrub that includes piles of rubble which have over-grown with bramble and were part of the original habitat creation. Immediately north-west there runs a strip of unmanaged hedgerow which has developed into a row of broadleaved trees. Most of the large fields are bounded by native species-poor hedgerows in varying condition, continuity and quality.
- 3.2.6 There are 6 ponds within the agricultural fields to the north, northwest and southwest, and a single large pond within the colliery area to the south.

Protected Species

- 3.2.7 The following text summarises the suitability of the area within a 500m radius of the application site to support various legally protected species, based on the habitats identified in the COFNOD data and by further desk study including a review of aerial imagery.

Amphibians

- 3.2.8 There are no ponds located within the site boundary and none within 250m of the application site. Six ponds are known to be present within farmland 250m-500m from the application site. There is one record for GCN within the field ponds and numerous records for them in the colliery pond, however the range of ponds will be likely to be used by GCN and to form part of the GCN meta-population that the area is known to support.
- 3.2.9 The terrestrial habitat present within the agricultural fields comprises improved grassland of low value to amphibians, scattered trees of negligible value and hedgerows in various states

providing some connectivity. The industrial estate itself offers little or no suitable habitat for amphibians but the former GCN mitigation area to the west of the production site could provide over-wintering opportunities. The former colliery whose pond supports good numbers of GCN offers suitable terrestrial habitat and hibernation sites. In summary it is acknowledged that GCN are present within 500m of the site and are likely to be present within suitable habitat connected to known GCN ponds or isolated habitat patches.

Badgers

3.2.10 The improved grassland pasture that dominates the land to the west of the site is potentially suitable for badgers, offering foraging value, habitat connectivity and places of shelter. It is likely that the substrate in the former colliery 250m to the southeast will be unsuitable for sett building and sub-optimal for foraging. The surrounding industrial estate land use is of negligible value.

3.2.11 No records for badgers were present within the COFNOD data within 500m radius (although there are records within 1km) and from studying the habitats it is concluded that badgers are absent from the application site and the wider industrial estate, and likely absent from <30m.

Bats

3.2.12 The existing industrial unit, within which the processes take place, is comprised of fire rated FMRC class 1 fire classification panels and corrugated panels. These building materials are unsuitable to support roosting bats given their poor thermal retention properties and the absence of any potential roosting features (PRFs) created in the construction of such buildings. The site has been used since 2001 and part of the structure was re-built in 2009/2010. This long-term and on-going use is likely to produce a level of daytime disturbance that will deter bat roosting. The site is also subject to level of security lighting during the hours of darkness.

3.2.13 There are no suitable mature trees that could provide bat roosting potential within the application site or the immediate surroundings. The hedgerows and linear features that surround the study area are likely to provide suitable foraging and commuting corridors for bats. Trees further afield may be of value to roosting bats but for the purpose of this study and its intentions, the study area is considered to be of low value as a foraging or commuting resource for bats.

3.2.14 There are no records for bats <500m of the application site. Whilst this does not discount the presence of bats locally, the absence of data does suggest that there are no significant roosts within the search radius. It is therefore concluded that roosting bats are absent from the application site and that the value of the site for foraging/commuting bats is low.

Birds

3.2.15 There are limited opportunities for nesting birds within the application site, owing to the operational nature of the site, the high level of disturbance and the minimal areas of any semi-natural vegetation or suitable buildings within which to nest.

3.2.16 Within surrounding land, including the aforementioned GCN mitigation area there are opportunities for nesting birds associated with hedgerows, scrub and scattered trees within the farmland and former colliery site. However, the predominance of industrial estate and

intensive agricultural land within 500m of the site means that the study area is of low value to foraging birds.

- 3.2.17 Records for the area include a mix of relatively common and widespread species of passerine, migratory songbird, and raptor. Overall, taking into account the absence of suitable nesting potential within the application site it is considered to be of low value to nesting birds.

Reptiles

- 3.2.18 The application site is comprised entirely of made-ground (buildings and hard-standing) and therefore is of negligible value to reptiles. The adjacent GCN mitigation area offers potentially suitable hibernacula and opportunities for sheltering reptiles, however the surrounding industrial estate is of similarly low value, with occasional hedgerows offering a degree of connectivity through the site. The agricultural land to the west is intensively managed but also comprises hedgerow boundary corridors, which may be suitable to support a small but sustainable reptile population. The former colliery site offers potentially suitable reptile habitat but there are no reptile records for that area.

- 3.2.19 There is one record for grass snake ~350m from the application site. There are no further records for reptiles within 2km of the site. It is therefore concluded that reptiles are absent from the application site and likely absent from the surrounding land.

Riparian Mammals

- 3.2.20 There are no main water-courses within 500m of the application site and just one minor ditch/drain located 200m to the southeast on the northern edge of the former colliery land. There are no semi-natural habitats within the application site and habitat within the surrounding land are of negligible value to any riparian mammals owing to their intensive management (agricultural grassland and hedgerows) and frequent disturbance from management and industrial activities.

- 3.2.21 No records for otter or water vole are found <500m of the application site, although there are records for within 1km associated with the Afon Alyn to the west. Overall, it is concluded that both otter and water vole are absent from the site and from the immediately surrounding land.

3.3 Notable Species

- 3.3.1 There are records for very few invertebrates and no records of hedgehog or polecat <500m of the site, all of which are listed as species of Principal Importance under the Environment (Wales) Act 2016. The site is generally considered to be of low suitability to support notable species owing to its industrial nature and the absence of any semi-natural vegetation.

- 3.3.2 No notable or locally rare species of flora were recorded within the study area, with floral records within the COFNOD data only starting at a distance of just under 500m from the production site.

3.4 Invasive Species

- 3.4.1 Five records for invasive non-native species (INNS) of flora listed on Schedule 9 of the Wildlife and Countryside Act 1981 (as amended) were provided by COFNOD, within a radius of 500m.

None of these have any bearing upon the outcome of this report and its purposes therefore shall not be considered again in this report.

3.5 Key Ecological Receptors

3.5.1 This desk study Survey has identified the following key ecological receptors associated with the study site:

- GCN; the species is known to be present locally, although there are no semi-natural habitats within the application site itself. *Local Value*
- Bats; there is no bat roost potential associated with the application site and only low value foraging and commuting opportunities. *Local Value*
- Nesting Birds; very low potential for nesting birds within the application site and low potential value associated with immediately adjacent land. *Local Value*

3.5.2 The protected species / ecological receptors not bullet-pointed above are considered to be of *less than local value*.

4 DISCUSSION

4.1 Waste Permit Application

- 4.1.1 The purpose of this report is to provide the client with a list of the 'ecological receptors', if any, that may be impacted by the process of producing animal bedding and conditioning agent in their Llay site. This has been fulfilled by the data search and subsequent discussion in this report.

4.2 Likely Impacts

GCN

- 4.2.1 There will be no change to the infrastructure resulting from the activities undertaken within the existing building and on site, and the surrounding land will continue to operate as per the existing baseline scenario. Therefore, whilst it is acknowledged that GCN are present locally to the site they are not considered to be present within the application site boundary, and no adverse impacts are anticipated.

Bats

- 4.2.2 There are no suitable roosting features present within the application site boundary or within the surrounding operational part of the site. Therefore, no adverse impacts are anticipated on roosting bats. There will also be no loss of habitat or other features that may be of use to foraging/commuting bats. However, any changes to the artificial lighting arrangement that is currently in place could have impacts on foraging/commuting bat activity.

Nesting Birds

- 4.2.3 There are no direct impacts anticipated on nesting birds as the existing building is of very low value and there will be no physical changes to the building itself. Therefore, the only impacts would arise from any additional disturbance as a result of potential change of use in the future. Any such impact is likely to be insignificant given the absence of semi-natural vegetation within the application site and the likelihood that very few birds nest locally to site.

4.3 Recommendations

- 4.3.1 There are no recommendations for further survey or mitigation measures with regard to GCN or nesting birds, as a result of there being no anticipated adverse impacts.
- 4.3.2 If the artificial lighting regime on site is to change as a result of any proposed change of use within the building, then advice on specific 'bat-friendly' lighting should be sought and acted upon to minimise impacts on foraging/commuting bats. Any new artificial lighting must be located and orientated in such a way as to avoid any light spillage onto the boundary vegetation and directed below the horizontal plane.

5 CONCLUSION

- 5.1 Etive Ecology Ltd was commissioned by Platts Agricultural Ltd to undertake a desktop ecological study and visual assessment of a former GCN mitigation area (which lies adjacent to the application boundary) to accompany and inform a re-submission of a waste permit application for the production of animal bedding (from pre-consumer wood residues and conditioning agent) at their production unit off Miners Road on Llay Industrial Estate North.
- 5.2 The desk study comprised the purchase of ecological data records from COFNOD and the use of other online resources, followed by the identification of the potential ecological receptors, an assessment of the likely impacts and recommendations if any, for mitigation measures.
- 5.3 The data search identified one statutory nature conservation site <1km (Llay Bog SSSI) and three non-statutory nature conservation sites. Protected species records for <500m of the site include GCN, numerous bird species and a small number of invertebrates.
- 5.4 The Platts production site covers an area of approximately 1.56ha situated off Miners Road on the Llay Industrial Estate North. The site is comprised of hardstanding with various buildings and containers around the perimeter. Immediately south, east and north-east are industrial estate plots comprising hardstanding with various units and buildings. To the north and south-west are agricultural fields with predominantly improved grassland. Immediately west is a strip of scrub which was created as a former GCN mitigation area, and also a strip of unmanaged scrub immediately to the north-west. The OS map and COFNOD records indicate that there are a number of ponds located 250m - 500m from the application site.
- 5.5 The original application for a waste permit for production of animal bedding from pre-consumer wood residues at the Platts production site, was turned down by NRW on the basis that no ecological receptors had been identified by the applicant (ECL Ltd on behalf of Platts). The permit application is to regularise the existing use of the existing building on site, with no physical changes to any of the existing land within the application site boundary. As a result, there will be no land-take or loss in any semi-natural vegetation or habitat. It is anticipated that ECL will use this report to assess any potential impact from additional noise and dust on the ecological receptors identified herein.
- 5.6 In conclusion, the application site has been found to be of low ecological value and the continuation of the existing use is not anticipated to result in any direct adverse impacts on GCN (considered absent from the site) or any other protected/notable species.
