A pre-planned visit took place on Thursday 5th October, 2017. Present was the Regulating Officer Julie Hughes and Steve Edwards and Andy Carson.

This was the first visit since the issue of the permit. The site was not fully operational but the Technically Competent Manager (TCM) Steve Edwards took me around the site and explained the processes which would be taking place on the site. This included waste acceptance/rejection, the weighbridge, areas where screening would take place and the storage areas of the resulting product.

At the office, we went through all topics within the first inspection check sheet. Following the meeting the notes were types up and sent to Mr Edwards for approval and signature. A copy of the final signed document is attached to this CARS form and will be held on the NRW public register.

The Environmental Management System was still in draft form. It was requested that this document be finalised and a copy submitted to NRW by Friday 27th October, 2017. The Regulating Officer received a copy of the EMS on the 25th October and will review and provide feedback in due course.

Mr Edwards has experienced difficulties with completing the waste returns spreadsheet as there was an issue with some of the drop-down boxes. Mr Edwards had contacted Judith Green in the NRW customer Contact Centre for guidance. The Regulating Officer also sent on an updated copy of the spreadsheet for future use.

There were no permit breaches recorded during this visit to the site.
