A visit took place on the 11th September, 2015 by Julie Hughes. The purpose of the visit was to inspect the site in relation to the surrender of Permit number EAWML 900038. Also present was Eilir Pritchard, Operator.

Prior to the visit I had received copies of all waste transfer notes relating to activity. All waste had been accepted from G & D Aggregates of Unit 5 Griffiths Crossing Industrial Estate. Caernarfon. LL55 1TS. All material accepted was as specified by the permit and the recovery v disposal statement.

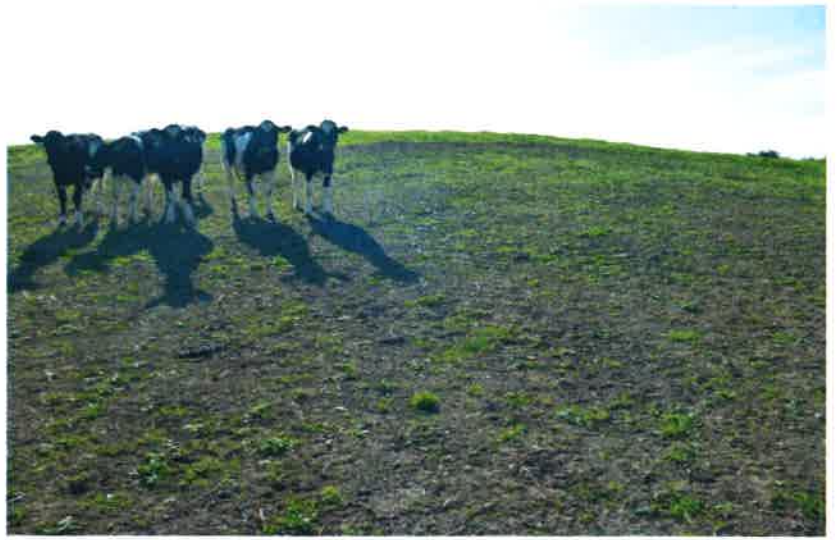
The permit allowed the acceptance of 2,100 tonnes of soil and stones (15 05 04) to infill and level agricultural land. A total of 1,379 tonnes of waste was accepted and this was found to be sufficient material to complete the works.

Due to the completion of the works the Operator had decided to surrender the permit to avoid further subsistence fees.

The area where the waste had been deposited complied with the permit plan. The materials used had no visible contaminants. All waste accepted onto site had been tested prior to acceptance.

The inspecting officer had no issues relating to the surrender of the permit.
