Maximum total suspended solids, effluent flow and COD all decreased compared to 2017.

pH ranged between 4.45 and 11.90, compared with 2.9 and 10.22 in 2017.

BOD was not reported for 2018. In response to the omission from the 2017 form, you stated that "the Monitoring of BOD has not taken place, this will be rectified as we investigate the equipment required to carry this out in our Laboratory (Next few weeks/March-April 2018)".
