WHEREAS

1. On the 17th August 1987 Associated British Ports applied to the Welsh Water Authority for consent to make a discharge of sewage effluent from the Sea Cadets Club Site (ABP Ref. No. D3) into controlled waters.

2. Consent was deemed granted on 18th September 1987 such that the discharge could lawfully be made provided it remained consistent with the nature, composition and volume described in the application until either,

- a) the Welsh Water Authority or successors gives consent unconditionally
- or b) 3 months after consent is refused or granted subject to conditions
- or c) the final determination of any appeal.

NOWTHEREFORE under Section 88 and Schedule 10 of the Water Resources Act 1991 and all other enabling powers, the National Rivers Authority **HEREBY GIVES YOU NOTICE** that the said discharge of sewage effluent will become subject to the conditions contained herein three months from the date of issue of this Consent.

1. The discharge shall consist only of sewage effluent from the sewage system serving the Sea Cadets Club Site at Port Talbot Dock.
2. The discharge shall be made in the manner and at the place specified as follows:-

Discharging via : a 4" drain
Discharging to : Port Talbot Dock
At OS Grid Ref. : SS 75800 88800
As shown marked X on attached plan No. BP0055703

3. The maximum volume of effluent discharged shall not exceed 2.5 cubic metres per day.
4. The maximum rate of flow of effluent discharged shall not exceed 1.0 litres per second.
5. The quality of the effluent discharged shall also comply with the following conditions from 1st January 1994:
 - i) The discharge shall not contain any solid matter having a particle size greater than 6 millimetres in any two directions.
 - ii) The suspended solids concentration (dried at 105 degrees Celcius) shall not exceed 150 milligrammes per litre.
6. Adequate facilities shall be provided for authorised officers of the Authority to conveniently obtain representative samples at any time of the effluent at the outfall.
