An incident notification was made to Natural Resources Wales on the morning of Tuesday 28 April 2015 concerning waste material being blown off site onto a neighbouring business unit. A video was also provided to Natural Resources Wales clearly showing the loose waste material being blown off site.

The video showed loose waste material being loaded into the trailer of an articulated lorry by a front bucket loader. When being dropped into the trailer, the loose waste items were being caught by the wind and blowing over the boundary fence.

Liaison has since taken place between site management and officers of Natural Resources Wales with improvement works to take place shortly in order to address the issue and prevent any further occurrences of this nature. In the interim all preventative measures should be taken to ensure there is no further escape of litter or loose items of waste from site.

On this occasion advice and guidance has been issued as a response. Should Natural Resources Wales received any further reports which are substantiated further enforcement action may be taken.
