This was a routine pre-arranged site inspection. Upon arrival I met with Jim Espley who accompanied me throughout the duration. Weather conditions were fine and dry with minimal wind.

This was my first visit to site, so the purpose of the visit was to familiarise myself with site operations taking place. Discussions took place within the site office with Jim Espley explaining the operations which take place before we both headed out into the permitted area for a full site walk around.

The site was operational, however appeared quiet during the inspection. Jim was able to explain the processes and procedures which take place on site and also point out the upcoming changes which are due to take place on site specifically in relation to the control of wind blown litter along the fence next to the recyclables bulking up bays.

Observations were made and pollution prevention advice was provided with regards to the storage of highway repair material which could have been placed on site with more care and consideration.

Following the walk around the permitted area I returned to the site offices and continued discussions with Jim Espley.

No issues were noted relating to noise, dust, litter, pests/vermin or mud on the highway.
