On 23 September 2019, Natural Resources Wales received a report of run off from land spreading at Coed Hywell, Llandegai, Bangor, LL47 4BG (**SH 258852 369341**) onto an adjacent public right of way.

This field benefits from a land spreading deployment held by PAR Contractors Ltd (**Deployment Reference: PAN-005715/ Permit Reference: EPR-KP3196EA**).

Verbal contact was made with PAR Contractors Ltd to request cleanup.

After receiving further information on the **24 September 2019** in the form of photographs which showed slurry entering the **Afon Cegin** officers attended the deployment site on **26 September 2019**.



Multiple spill locations were observed within 5 m of the field boundary. PAR operatives on site confirmed that an umbilical had split on the Morning of the **23 September 2019**

No report had been made to NRW to report the umbilical failure and slurry release.

This is a category 3 permit breach contrary to condition 4.3.2. **"Written Confirmation of actual or potential pollution incidents and breaches of emissions limits shall be submitted within 24 hours"**.

Action: Submit incident report for the release on **23 September 2019** by **Friday 4 October 2019** using the contact details below.

In future report actual or potential pollution incidents and breaches of emissions in writing within 24 hours.
