4. Details of our assessment

On 4th January 2022 AIUK submitted a Schedule 5 Notification to Natural Resources Wales (NRW) informing NRW that AIUK's aluminium (Al) discharge to sewer on 26th November 2021 had exceeded the emission limit value (ELV) .

The Al concentration was 2.1mg/L; the emission limit (ELV) value is 2.0mg/L. A non-compliance has not been issued as the exceedance is less than 10% above the ELV, which is probably within the uncertainty range for the analytical method.

The result was from a sample was taken by Welsh Water which is why AIUK have only just been made aware of the exceedance. A split sample, taken at the same time and analysed by AIUK's external laboratory, gave an Al concentration of 1.6mg/L. The in-line Al monitor recorded a value of zero at the same time.

AIUK should try to identify the reason for the difference between the WW result and that from i2 Analytical.

The poor performance of the in-line Al monitor is currently being investigated by the supplier and AIUK. NRW look forward to hearing the results of their investigations.
