4. Details of our assessment

Bioaerosol Monitoring report was submitted by the operator for monitoring carried out on 9th December 2021. This was the same day as I carried out a site inspection and there were concerns about odour emissions from the neighbouring anaerobic digestion facility and whether this might also result in the facility emitting bioaerosols.

The monitoring report shows that the compositing operations at Crugmore Farm did not result bioaerosol emissions above the permitted threshold. It also shows that, although the wind direction was from the neighbouring anaerobic digestion facility, the upwind sample shows only baseline concentrations of bioaerosols and the results for the downwind samples were no different. This indicates that even if there is noticeable odour emissions from the anaerobic digestion plant, there is no additional bioaerosol loading.
