4. Details of our assessment

Linda Warrick and Eleanor Davies attended the site. We met with Bob Seeley the contracts manager. We discussed the impact Covid-19 pandemic was having on the clinical waste industry. Mr Seeley highlighted that there have been issues with waste not being picked up but has said this has now been sorted.

Mr Seeley went through his EMS on site and we looked at a number of consignment notes from the various outreach community hospitals. I discussed that I would conduct an audit on the consignment notes in the near future. Mr Seeley has forwarded me 3 months of consignment notes.

We discussed Technical Competence for the site, as the previous TCM cover had now moved onto another job. Mr Robert Poyer of Natural UK will now act as the TCM cover until Mr Seeley updates his continuing competency.

We inspected the storage compound. The site is well run and organised with clear labelling to segregate the various clinical wastes. Each eurocart is clearly labelled.

We asked to look into one of the non infectious 18 01 04 eurocarts and identified a bag clearly contaminated with blood. I asked for this to be put aside and a non conformance report forwarded to me to identify the reasons for this occurrence. The Ward B2 was identified and training has been addressed. There have been times in the past with waste getting into the wrong bags and this has been addressed with awareness training.

A non conformance report was forwarded and I am happy that the procedure for action against this non conformance were followed through. It is important that infectious and non infectious waste streams are kept separate. Otherwise the whole non infectious waste stream (18 01 04) will have to leave as infectious waste (18 01 03*). There have been no issues raised with mixing by Natural UK and SRCL who are the onward processors of these waste streams.

Due to the current pressures on the NHS with staffing issues, it is important that eurocarts are regularly checked by the transfer station staff to ensure the correct waste is placed in the correct cart.

The impermeable pavement was in good order and the drains were all clear and free from litter.
