SCHEDULE 3 TABLE S3.2 of the permit specifies a bio aerosol limit of 500 CFU/m3 for Aspergillus Fumigatus.

The permit limit for Aspergillus Fumigatus was exceeded on the 25/11/2021. The reading was 1000cfu/m3 for SP2 and SP4, following the M9 monitoring guidance. This is double the permit limit and therefore is scored a CCS 3 a minor breach.

Measures are in place through the agreed Compost Action Plan to address these issues. Monitoring should continue as scheduled
