Inspection

The transfer pad was looking reasonably clean and tidy at the time of the inspection. Relatively little garden waste was on the pad.

Litter was being collected from around the back of the bay and from the skip storage area on the landfill.

Odour and bird control measures were in place and appeared to be working.

There is a considerable amount of giant hogweed growing along the entrance road. This needs to be treated before it is able to set seed and spread further. This has been raised in previous years but efforts to eradicate it do not appear to have been successful.

Waste returns

Breach of Permit Condition 4.2.2 - Failure to send in waste returns for the January to March 2015 quarter. Please ensure that these are submitted without further delay. For permit number BP3391EL the return should include the municipal and garden waste. The food waste should be included on the return for permit number AP3739KS.
