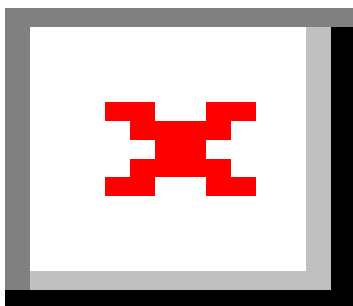
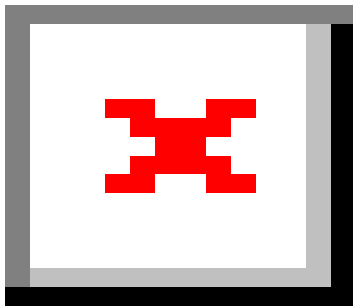

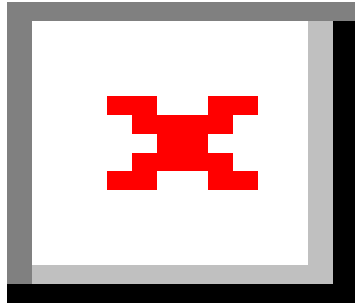
This was an unannounced inspection by regulating officer Steven White, Mike Groves was on site at the time of the visit and accompanied me around for some of the inspection

There were a couple of mounds of pebbles from Rhyl Marina which had been brought to site under licence from LA (see photos below)

The crusher and trammel were operational at the time of the visit; there were no issues with regards to dust from the machinery on site.

Site perimeter was checked - no issues

The yard at front of the site is to be renovated and used by local scaffolding firm

KM Environmental has recently gone through the PAS inspection for the site and has passed, the certificate has been sent to NRW and is saved on the site file.

Fuel tank checked - this is a sealed unit, no leaks or spillages were observed

The destinations of waste wood and metals from the site was checked: Wood - Thorncliffes; Metal to Lelo. Both are permitted sites and are able to accept these wastes.
