Routine site inspection conducted by Environment Officer Leon Williams.

Officer was accompanied by Mike Groves for inspection of the site. Mr Groves explained to Officer that the company had recently passed the PAS (Publicly Available Standard) 402:2013 assessment.

A complete site tour was conducted. All waste types observed on site were compliant with permit and were located within sites permitted boundaries. Low levels of contaminants were observed in untreated stockpiles of waste.

Screening activities were operational during inspection of site. Mr Groves explained how dust control measures are implemented on site. No amenity issues relating to dust, noise, odour, litter or pests were observed during the inspection.

Incoming waste transfer notes and outgoing invoices were inspected, all of which were duly completed. Hazardous waste consignment note records were also made available for inspection following request by Officer.

Mr Groves gave a demonstration of the sites security camera systems. The system allows for real time, 24/7 surveillance at the site.

A discussion was held relating to the sites maximum storage capacity which is currently at 2500 tonnes. Mr Groves enquired about how this quantity could be increased. Officer explained that in order to increase the capacity an application to vary the permit would have to be submitted to NRW. Links to the application forms have since been emailed to Carli Hildebrant.

Officer also recommended that routine inspections of the sites oil interceptors are added to the sites inspection checklist.
