This non-submission is a breach of permit condition 6.2.2. As a direct result of this breach of permit condition a CCS score has been applied.

You are required to submit the missing returns for quarter 1 2016 to waste.returns@cyfoethnaturiolcymru.gov.uk by the 2nd June 2017. You are also required to implement with immediate effect a management system to prevent this breach of permit from occurring again.
