Routine site inspection conducted by Environment Officer Leon Williams accompanied by Ken Groves.

Waste stockpiles deposited on site where compliant with the requirements of the site license. All waste stockpiles were seen to be stored on hardstanding as required by condition 2.1 of the license.

The highway leading out of the site was well maintained and remained free of mud and debris. The site's identification board was inspected and was seen to contain all the relevant information required by condition 3.1.3 of the site license.

With regards to section 1.1.2 of the site's working plan (Version 1.2), it is noted that metals which are extracted during the crushing of waste process are mechanically transferred to designated skips for recycling. Metal waste was seen on site during the inspection to be stored outside of the skips on hardstanding. This minor procedural error has on this occasion been recorded as a Category 4 breach against condition 5.3.1 as there is a low likelihood of consequential environmental impact. Please ensure that metal waste is stored in the relevant skips as outlined in Section 1.1.2 of the site's working plan in the future.
