The boundary fence was damaged which allows unauthorised access to the site. Waste has been removed from site and disposed of around the area of the damaged fence. This is reported to be a common problem at this site. A solution to this issue needs to be found with some urgency. CCTV is operational at the site and identification of the culprits should be possible and appropriate enforcement action taken. The council may consider replacing the metal fence with another material that cannot be damaged so easily. Please contact me when the fence has been repaired.

The site was tidy and waste well segregated.
