This was an unannounced inspection carried out by regulating officers Steven White and Amy Henderson, site director Tony Williams was initially not on site but joined us later on in the visit.

As officers entered the site we were able to observe distinct piles of inert waste materials, these were split into: Soils (post-treatment); Soil, stones and rubble (pre-treatment); Soil and stones (pre-treatment) and; Soil and stones (mid treatment). These are shown by the photos below. There were no issues with the types and quantities of waste material on site.

Prior to Tony Williams' arrival we spoke with one of the site operators who showed a good understanding of the site operations and permit requirements.

It was estimated that there was approx. 30,000T of waste material (prior to treatment) on site, this is below the maximum amount specified on the permit (50KT) allowed on site at any one time.

We checked the quarantine skip where large bits of material, such as metals/plastics/wood, are kept prior to removal from site. See photo below.

A Waste Returns check was carried out for 2018 and for the first two quarters of 2019; this showed the following figures for waste received and removed from site:
