The Fugitive Emissions Review for 2020 was received on 10th January 2022. It was due on 31st March 2021. ZF had prepared the report but omitted to send it to Natural Resources Wales (NRW). NRW have to issue a Cat4 non-compliance for this late submission, even though it is most unusual.

There were no fugitive emissions from the site in 2020. The report reviews all the measures which are in place to minimise fugitive emissions from the site.
